OSHP DELEGATE REPORT (JUNE 2005)

OSHP was represented by elected delegates Anetta Harrell, Barbara Poe, and Dennis Thompson at the recent ASHP Annual Meeting in Boston, Massachusetts. The 57th Annual Session of the House of Delegates was held on Sunday, June 12th and Tuesday, June 14th, 2005. In preparation, all three delegates attended the Regional Delegate Conference in Dallas, TX, this past May. OSHP Delegate Report *(continued)*

Overall, there was considerable debate on policy recommendations at this year's House of Delegate meeting with twelve policies amended at the first session of the House. Significant discussion and debate were focused on the subjects of coverage for the uninsured, clinical trial registry, and developing management and leadership competencies within health-system pharmacy (given that 80% of current pharmacy directors will retire within the next 10 years). Please contact one of your Oklahoma Delegates (dennis.thompson@swosu.edu, bpoe@nrh-ok.com, anetta.harrell@pfizer.com) or ASHP (www.ashp.org) for further information regarding any of the above policies.

The ASHP Nominations Committee presented the list of candidates for President, Board of Directors, and Chair of the House of Delegates. Candidates for ASHP President include Cynthia Brennan (Washington) and Bonnie Senst (Minnesota); candidates for ASHP Board of Directors include Charles Jastram (Louisiana), Stanley Kent (Illinois), Sheila Mitchell (Tennessee), and Michael Sanborn (Texas). All eligible OSHP members are urged to vote when the ballots are mailed in the next few weeks. Marjorie Shaw-Phillips (Georgia) was elected to her third and final term as Chair of the ASHP House of Delegates by the House of Delegates.

Finally, the ASHP Leadership Agenda for 2005-2006 includes the following areas of focus for the organization over the coming year:

- A) Promote fail-safe medication use in health systems
- B) Foster evidence-based medication use in health systems
- C) Expand access to the patient care services of health-system pharmacists
- D) Help health-system pharmacists deal with the affordability and accessibility of pharmaceuticals
- E) Foster an adequate supply of qualified practice leaders, pharmacists, and pharmacy technicians in health systems

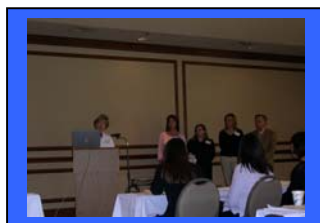
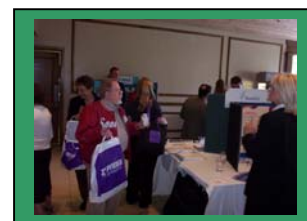

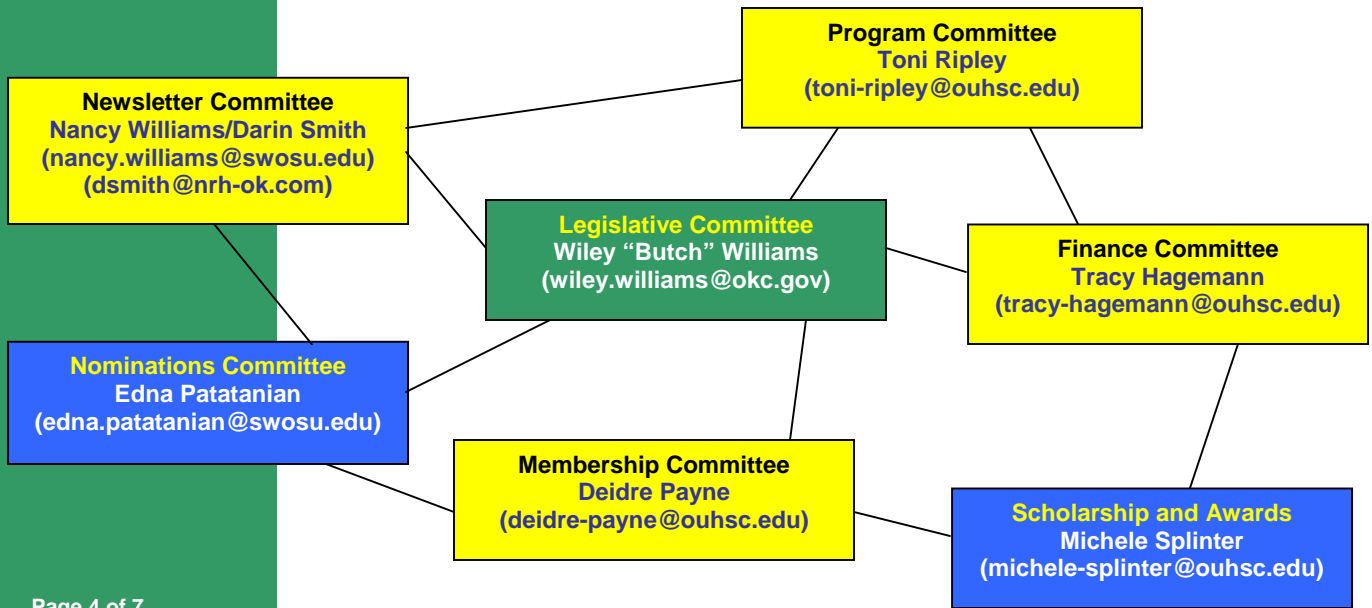

OSHP Clinical Pearls

SYMLIN® (pramlintide acetate) Subcutaneous Injection

Background: Symlin® Injection is an antihyperglycemic agent used in patients with diabetes (type 1 or 2) treated with insulin. Pramlintide is a synthetic analog of human amylin, a naturally occurring neuroendocrine hormone synthesized by pancreatic beta cells that contribute to glucose control during the postprandial period.

MOA: Pramlintide acts as an amylinomimetic agent by: 1) slowing gastric emptying time thus reducing the initial postprandial rise in plasma glucose; 2) preventing postprandial rise in plasma glucagon; and 3) promoting satiety leading to decreased caloric intake and potential weight loss.

FDA Indications:

- 1) Type 1 diabetes, as an adjunct therapy in patients who use mealtime insulin therapy and who have failed to achieve desired glucose control despite optimal insulin therapy.
- 2) Type 2 diabetes, as an adjunct therapy in patients who use mealtime insulin therapy and who have failed to achieve desired glucose control despite optimal insulin therapy, with or without a concurrent sulfonylurea agent and/or metformin.

Administration: Administered subcutaneously immediately prior to each major meal consisting of ≥250 kcal or containing ≥30 g of carbohydrates.

Dosing: When initiating Symlin®, an insulin dose reduction is required in order to minimize risk of insulin-induced hypoglycemia. Decrease preprandial, rapid- or short-acting insulin, including fixed-mix insulins (e.g. 70/30) by 50%.

- 1) Insulin-using Type 2 Diabetics: Start with 60 mcg subcutaneously, immediately prior to major meals, and increase to a dose of 120 mcg as tolerated.
- 2) Insulin-using Type 1 Diabetics: Start with 15 mcg subcutaneously, immediately prior to major meals, and titrate at 15 mcg increments to a dose of 30-60 mcg as tolerated.

Pharmacokinetics:

Absorption: approximately 30-40% subcutaneously
 Distribution: not extensively bound to blood cells or albumin
 Metabolism and Elimination: primarily renal

Adverse Effects:

- 1) Hypoglycemia
- 2) Nausea and vomiting
- 3) Anorexia, headache, fatigue, dizziness, coughing
- 4) Local Allergy

Contraindications:

- 1) Known hypersensitivity to Symlin® or any of its components
- 2) Gastroparesis
- 3) Hypoglycemia unawareness

Drug interactions: Patients currently taking drugs that alter gastrointestinal absorption and agents that slow intestinal absorption. Symlin® may potentially alter the absorption of oral medications.

Dosing Adjustments: No dosage adjustments in patients with moderate to severe renal impairment (CL_{cr} >20 to ≤ 50 ml/min)

Storage:

Unopened vials: refrigerate at 36-46 °F (2-8 °C), do not freeze. If frozen or overheated discard vial.

Opened vials: can be kept at room temperature or refrigerated for 28 days, temperature not to exceed 77 °F (25 °C).

Discard after 28 days.

 Potential sources of error relating to Symlin® use include:

- 1) Dose confusion (dosed in mcg, available as 0.6 mg/mL, 5 mL vial, recommended to administer using U-100 insulin syringes)
- 2) Confusion with other insulin products
- 3) Abbreviations and dose designations

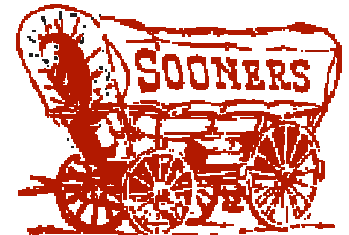
